

Terms and Restrictions of Logo Use for Individual Certified Specialist in Psychometry

The Board of Certified Psychometrist (“We”, “Us”, “Our”), own the Certified Specialist in Psychometry logo (the CSP logo). This agreement sets out the terms and restrictions on which we authorize you (the Certified Specialist in Psychometry) to use the CSP logo.

- 1) Your right to use this image is non-exclusive. The Board of Certified Psychometrist may grant similar or other rights to other persons or entities.
- 2) Only use the CSP logo while you are a current Certified Specialist in Psychometry and only to promote yourself as a Certified Specialist in Psychometry.
- 3) Only use the CSP logo in its entirety as shown in the electronic copy we provide you, except that you may alter the size, maintaining proportion, of the CSP logo and may use the CSP logo in black and white.
- 4) Ensure that all of your advertising and publications (excluding stationery or signage), in any medium that features the CSP logo includes the following statement, either in writing or orally, as applicable to the medium: *Check the CSP Register at <http://PsychometristCertification.org> to ensure current certification.*
- 5) Do not use the CSP logo in any way that could mislead the public or bring the Certified Specialist in Psychometry into disrepute.
- 6) Immediately stop using the CSP logo if you cease to be a Certified Specialist in Psychometry or if we direct you to do so.
- 7) Immediately inform your employer if you cease to be a Certified Specialist in Psychometry or if we direct you to stop using the CSP logo.
- 8) Your right to use this image is non-transferable. You may not assign your right to use the CSP logo to anyone else.
- 9) Your right with respect to this image is limited to use. You will not acquire any ownership or other interest in these images by using them, and you may not sell, distribute or take other such action with respect to them.
- 10) Do not register or apply to register any other sign/symbol/mark that is, in our view, similar to the CSP logo either while you are a Certified Specialist in Psychometry or at any other time.
- 11) Do not dispute our ownership of the CSP logo at any time or register or apply to register the CSP logo.
- 12) Do not forward to any person or other organization the electronic copy of the CSP logo we provide you or any copy of that electronic copy (in any form), except as necessary to enable another person to organize or create material intended to promote you as a Certified Specialist in Psychometry.
- 13) Indemnify us against all loss, damage, liability, cost and expense suffered or incurred by us as a result of your breach of these terms, including where you misrepresent yourself as being a Certified Specialist in Psychometry.
- 14) You understand that if you breach the terms of this agreement action may be taken against you.

We reserve the right to change the terms of use of the CSP logo or replace the CSP logo with another logo at any time and you agree to comply with any such changes. The Board of Certified Psychometrist may revoke your permission to use this image at any time and for any reason. Upon notice from the Board of Certified Psychometrists that your permission has been revoked, you must stop all use of these images immediately.
